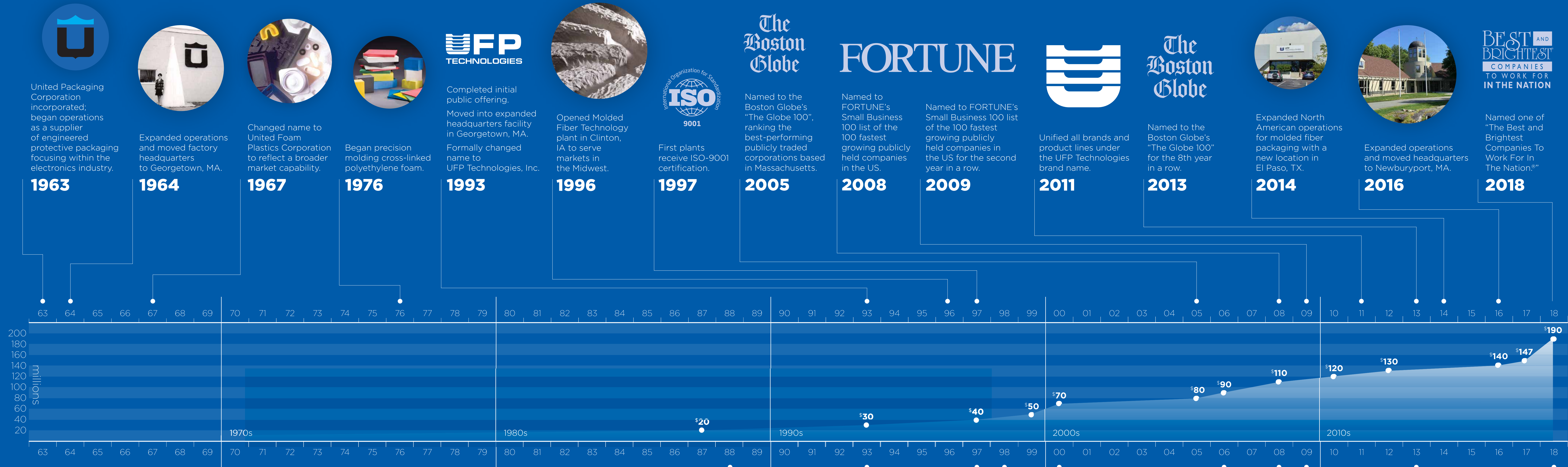

Acquired Simco Industries of Roseville, MI to expand production of automotive interior trim components.



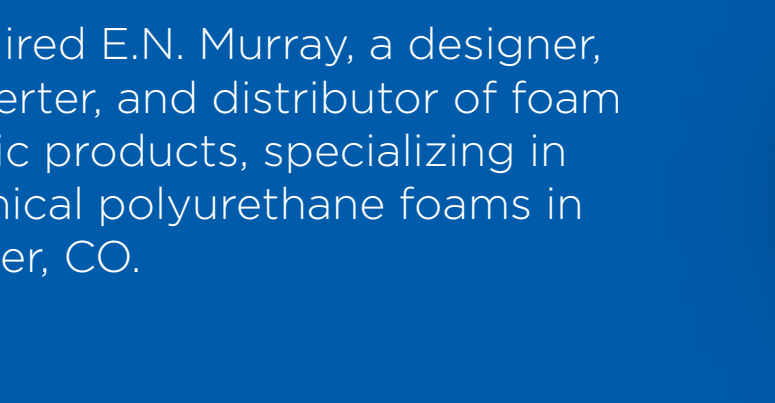
